TERMS & CONDITIONS

Definition: The term 'Exhibition' shall mean "Furniture Furnishings & Home Décor Expo". The term 'Exhibitor' shall mean the party and also includes all its employees, agents, or representatives to whom space has been allotted in the exhibition. 'Exhibition Manual' shall mean the handbook prepared by the organizer which carries such regulations which seems reasonable to the organizer relating to the Exhibition, the Venue and the Exhibitor's attendance and conduct at the Exhibition and the term 'Organizer' shall mean ACCPRE Expositions.

Agreement: A binding contract shall come into existence between the Exhibitor and the Organizer on acceptance & signing of the Application for Participation form in writing by the Organizer. No Changes to this Terms shall be valid unless signed in writing by the duly authorized representatives of both the Exhibitor and the Organizer.

Allocation of Stands: The basis of Allotment will be neutrality, aesthetic appeal, conformity with floor plan layout and product groups. Allocation will be subject to receipt of all advance payments. Allocation of stand number's location will be communicated in writing to all applicants by the organizers and these conclude the contract for participation in the exhibition between the organizers and exhibitors.

Alteration of Space Allotted: The organizers reserve the right at any time, and from time to time, to make such alterations in the ground plan of the Exhibition, as may in their opinion be necessary and to alter the shape, size of position of the space allotted to the Exhibitor. However, no alteration to the space allotted will be made in such way as to impose on the Exhibitor any greater liability for rental than that undertaken in the contract.

Obligation of Exhibitors: On confirmation of the stand allocation, an Exhibitor is obliged to make payments for the balance cost of participation, and cost for additional services availed of, as per schedule. Failure to adhere to the payment schedule will lead to forfeiture of all payments made. An Exhibitor is bound by these conditions of participation and Rules and Regulations for Exhibitors issued from time to time by the organizers and are obliged to enforce compliance thereof from his staff, agents or representatives. The Exhibitor shall always observe and comply with the Exhibitor Manual at all times. The Exhibitor remains obliged to participate even if the Exhibition is postponed for reason deemed necessary by the organizers.

Cancellation & Reduction of Space: In case of cancellation or withdrawal from participation of the stall by any Exhibitor, the paid amount would be forfeited. Reduction of space may be allowed by the organizers at their discretion and without assigning any reason elect whether or not to accept any reduction request.

Payment Terms & Conditions: The Exhibitor shall pay the 50% of the participation fee as agreed upon on signing of the contract, and the balance 50% of the participation fees shall be paid before 30 days prior to the inauguration date of the Exhibition.

Possession of Exhibit Space: If the stall cost is not fully & finally paid by the exhibitor, they will not be allowed to take up the allocated exhibition space and will not be given any consent to occupy /construct / erect the space booked in the exhibition. In case of non-payment of exhibition fees in full, all participation fees paid till date will stand forfeited and the balance of the participation fees as agreed in the contract will be recoverable, as liquidated damages from the exhibitor. The Organizer shall be fully entitled to utilize the booth/ space / site remaining vacant due to non-payment of participation fees in full which had been earlier reserved or allotted to any exhibitor in any manner as the Organizer shall deem fit to recover from the exhibitor any expenditure incurred in doing so. The Exhibitor hereby agrees to display all their exhibits at the allocated exhibition space before the opening of the event. An authorized person from the exhibitor organization must be present to take possession of the shell / bare space. The exhibitor hereby indemnifies the Organizer against any damage to the shell space, bare space, part of the event venue allotted to them and will be liable to pay the damage charges as decided by the respective owners of the shell space, bare space, or event venue. It is compulsory for the exhibitor to obtain a possession certificate from the Organizer after full & final settlement of the stall rentals payable for the setup day.

Promotions & Demonstration's: The Exhibitor should inform the Organizer in writing for usage of Audio-Video equipment's for promotions / demonstration purposes. The usage of the Audio-video equipment by the exhibitor shall not in any way obstruct, hamper, or in any way infringe upon the right of peaceful usage of Exhibition space / booth by neighboring exhibitors in the exhibition. The usage of audio-video equipment is limited to the exhibitor booth / space and in case of any such complaints by the neighboring Exhibitors, the Exhibitor playing the audio-visual promotion / demonstration or loud music will be asked to immediately evacuate the exhibition space, the Organizer reserves the right to charge the Exhibitors playing music, any fees, penalty, or other charges that arise due to the playing of music at their allocated exhibition space or any other action will be taken by the Organizer which they deem fit.

Contests & Activities: The Exhibitors are not allowed to organize any contests and any such other activities on their own without the prior written permission of the Organizer in the allocated stall space or otherwise.

Usage of Organizers Intellectual Property (IP): The Exhibitor should inform & obtain written permission from the Organizer for usage of Organizer's any Intellectual properties (IP) such as logo, name of the event or any other IP which is related to the event, exhibition or business related to ACCPRE Expositions. The usage of Organizer's IP by exhibitor should not infringe any rights of the Organizer related to the said IP. The exhibitor hereby agrees to indemnify the organizer from any claims or damages arising due to the unfair usage of the Organizer's IP by the Exhibitor.

Rights of Organizers: The organizers reserve the following rights:

- To reject any application for space without assigning any reason.
- To amend these conditions for participation and additional Rules and Regulations for participants from time to time, this shall be binding on all participants.
- To change the stand location or to make certain changes, alterations, curtailments in the final allotments of stall areas with respect to that originally booked by the exhibitor.
- To postpone, curtail, extend, or abandon the exhibition or close some or all sections of it temporarily or permanently, if unforeseen circumstances so require. In such an eventuality, no exhibitor shall be entitled to withdraw from the contract or to claim any compensation or damage.
- To refuse permission to an exhibitor to clear their stand / space if he has not discharged all debts to the organizers, and to remain in possession / retain their exhibits or other goods as collateral security till the debts are cleared and charge demurrage and administrative charges.

Insurance Coverage & Organizers Indemnity: The responsibility is on the exhibitor to obtain insurance coverage against all risks arising from the to and fro transport of exhibits and their display during the Exhibition, particularly against theft, etc. A comprehensive insurance is recommended. The Organizers shall not be liable for personal injuries and material damage including theft of any exhibits/ goods. To be bound by the provisions of these conditions for participation, the exhibitor expressly exempts the Organizers from any claims for damages that may be made by third parties.

Imported Exhibits / Foreign Principals: As per directives of India Trade Promotion Organization, the nodal agency attached to Ministry of Commerce, Govt. Of India, which approves all International Exhibitions, Duty – free import facility (Under ATA Carnet or Re Export Bond supported by the Bank Guarantee) is available to only foreign exhibitors who have paid participation charges in foreign exchange at the rates applicable to foreign exhibitors. Indian exhibitors interested in displaying exhibits imported from foreign principals, must ensure that each of their foreign principals register as an exhibitor, on payment of space charges. With appropriate space required. At the request of Indian exhibitor and foreign principals, an integrated stall with their combined space will be provided.

General Rules: In addition to the above the exhibitor shall abide by general rules of the venue. For safety and maintenance as well as for aesthetic appeal. No hoarding, banners, standees, etc will be allowed on the premises or on the roads in the vicinity. Exhibitors must take extra care to ensure that there is no damage to the floor or structural property of the venue.

Permission/Approvals: All verbal agreement, permission, individual approvals, or special authorization shall be deemed to be valid only if confirmed in writing by the organizers.

Exhibition Layout: The organizer reserves the right to make amendments in the exhibition layout, including re-locating the booths; without notifying the exhibitors. The stall numbers cannot be changed even if the participant decides to shift location of the booth on the exhibition floor.

Failure of services: The organizers will use their best endeavours to ensure the supply of the services of the venue, and of the authorized contractors, but they shall not incur any liability to Exhibitor for any loss or damage if such services shall wholly or partially cease to be available.

Force Majeure: Under the conditions of force majeure, which also include strike, lockout, closure, riot, the organizers reserve the right to alter the opening dates and duration or curtail, cancel, or suspend in whole or part of the Exhibition. In such an event, the Exhibitor is entitled neither to rescind the contract nor to claim any compensation or damages. In case of cancellation of Exhibition, refund will be made after deducting the proportionate cost already incurred by the organizers, and the cost of any additional services provided to the Exhibitor.

Final Decision: In case of any dispute in interpretation of conditions for participation, or between exhibitors, the final decision of the Organizers namely ACCPRE EXPOSITIONS, shall be binding on all parties.

Domicile and Jurisdiction: The implementation of these regulations or supplementary stipulations laid down by the organizers relating to the exhibition shall be deemed to be domiciled at the office of the Mumbai Courts. All disputes arising shall be judged according to Indian Laws and subject to Mumbai jurisdiction only.
